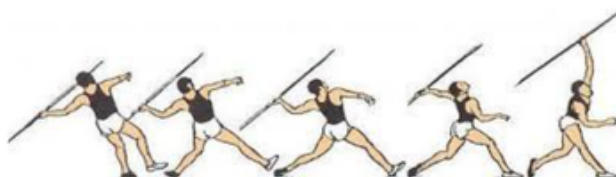


Jaguar Javelin Club
