Our Board meets once a month. The board is a working board which means every person serves on a committee and assists in all of our events in some capacity. It is understood that a board member may not be able to physically participate in all events; however, each event is comprised of many working parts that allow each person to utilize their talents and knowledge.

Fundamental expectations of all board members include:

- serve as a community ambassador to create and build a positive image of the contributions made by USD232EF to benefit the students, teachers and public schools in our community;
- attend and participate in at least seventy-five percent (75%) of all scheduled Board meetings typically held once a month;
- attend and participate in all USD 232 Education Foundation fundraising events whenever possible;
- serve as a school liaison to at least one school in USD 232;
- actively participate in at least one Standing Committee;
- regularly provide ideas, information and suggestions for both program and fundraising activities to the Executive Director and/or appropriate Board members;
- regularly identify and cultivate prospective donors and supporters for USD232EF;
- regularly provide names of prospective donors to the organization for inclusion on general mailing lists, event invitation lists, etc.;
- assist in soliciting funds from selected prospective donors during special “fund drive” periods of activity.
- Board members nominated and elected as officers shall attend Executive Committee meetings, as scheduled, in addition to other responsibilities.
- Board members shall serve a two (2) year term renewable for a maximum of six (6) consecutive years
